

**TAX LEVY ORDINANCE  
TOWNSHIP**

**ORDINANCE No. 2024-25- 6**

An ordinance levying taxes for all town purposes for Pin Oak Township, Madison County, Illinois, for the tax year 2024, collectible in 2025.

BE IT ORDAINED by the Board of Trustees of Pin Oak Township, Madison County, Illinois, as follows:

SECTION 1: That the sum of ninety thousand, six-hundred eighty-four dollars (\$90,684.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law.

SECTION 2: That the amount levied for each object and purpose shall be as follows:
